

PointsBet 75" TV Giveaway Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

GENERAL: In these Official Rules, "you" or "your" or "entrant" means the person who has entered this Sweepstakes. By entering in this Sweepstakes, you agree to be bound by the terms and conditions contained in these Official Rules. This Sweepstakes is governed by U.S. law and subject to all applicable federal, state and local laws and regulations.

SWEEPSTAKES ENTRY PERIOD: This Sweepstakes begins at **9:00 AM CT** on **9/7/2020** and ends at **5:00PM CT** on **11/2/2020** (the "Entry Period").

HOW TO ENTER: You may enter this Sweepstakes by completing an entry blank at participating PointsBet sports betting locations during the entry period. A raffle box will be displayed in locations for all entry blanks.

ELIGIBILITY: This Sweepstakes is sponsored and administered by PointsBet Illinois LLC ("Sponsor"). This Sweepstakes is open only to persons who are 21 years of age or older and who are legal residents of Illinois. Void where prohibited or restricted by law. Employees, their immediate families, and household members (whether related or not), of Sponsor, or Sponsor's affiliates, subsidiaries, or divisions (collectively, the "Sponsor Parties") are not eligible to enter this Sweepstakes. This Sweepstakes is subject to all applicable United States federal, state, and local laws. Sponsor reserves the right to verify the eligibility qualifications of any winner.

PRIZE: One (1) person will win a 75" Samsung UHD 7 Series Smart TV ("Prize"). Winner will be notified at approximately 11 am CT on November 3, 2020. The Prize is non-transferable and may not be substituted or exchanged for cash value. Odds of winning Prize depends on the number of eligible entries received.

All costs and expenses associated with the Prize acceptance and use not specified herein as being provided, including travel, meals, lodging, and incidental costs incurred by accepting the Prize are the sole responsibility of the Winner. A random drawing and awarding of the Prize will be conducted under the supervision of the Sponsor whose decisions are final and binding in all matters pertaining to this Sweepstakes. Entrants agree to be bound by these Official Rules and the decisions of the Sponsor. Sponsor reserves the right to reject
