Preference shall be determined by the most recent race date. Should an event overfill, ICF horses shall be given first preference in the case of common race dates.

ICF horses receive 50% allowance of the base claiming price. All races may be considered sub races.

Wins for a purse of \$3,500 or less shall not be considered (Maiden races excluded)

**QUALIFYING STANDARDS EFFECTIVE** : PACE: 2:01 (3 YO 2:02; 2 YO 2:04) TROT: 2:03 (3 YO 2:04; 2 YO 2:06) 5/8 or 1/2 mile track allowed one second - within 60 days.

Filly and mare trotters may draw inside.

Trainers are expected, at time of entry, to provide accurate information regarding Lasix. Failure to do so may be cause for civil penalties assessed by the stewards.

The Race Secretary reserves the right to place horses that did not race in Illinois in their last two starts or show an Open in one of two last starts. Events may be combined in order to fill races. Said races shall carry the purse that represents the majority of the horses in the race.

**IRB RULE SECTION 605.40 VALID HEALTH CERTIFICATE** All equines entering Illinois must be accompanied by a certificate of veterinary inspection (health certificate) issued by an accredited veterinarian within 30 days prior to entry, and an entry permit number issued by the IL Dept. of Agriculture.
