Horses that are on the stewards's list shall be eligible for legs, provided the horse has a clean line in accordance within the published "days" at time of entry.

Horses that have earned sufficient points to compete in the final/consolation must show a clean line within the published "days" at time of entry.

Two year old divisions shall consist of four (4) qualifying legs as follows:

Leg 1 - ISFCS Eliminations; Leg 2 - Suburban Downs @ Springfield State Fair Grounds; Legs 3 & 4 @ Hawthorne Racecourse

Three year old divisions shall consist of four (4) qualifying legs.

Legs 1 & 2 Suburban Downs at Springfield State Fairgrounds; Legs 3 & 4 at Hawthorne Racecourse

Separate nominations for the ISFCS are required to be made with the Illinois Dept. of Agriculture.

Points shall be earned as follows: 1st - 50; 2nd - 25; 3rd - 12; 4th - 8, 5th - 5; 6-12th - 1

In the event of a dead heat, points shall be combined and divided equally between affected horses.

The horses with the top 10 (ten) points entered in each division shall qualify for the championship final.

Horses that have earned sufficient points to compete in the final shall not be eligible for the consolation.

In the event thirteen (13) (two year olds eleven (11)) or more horses are entered in a leg, the leg will be split and raced as divisions.

The open division shall consist of an elimination race with the top (10) finishers that enter advancing to the final. (Ties broke by lot)

In all NOC Finals and Consolations each horse finishing 6th through last shall receive two (2) percent of the purse.

The remainder of the purse shall be divided 50-25-12-8-5 for the horses finishing first through 5th. Horses must start to receive purse money.

*All entry fees shall be paid prior to horses going to the gate. There shall be no refunds for horses that do not start.

**Consolation races shall be limited to those horses that earned minimum one point.

**Consolation races will be held provided a minimum of six (6) betting interests are entered and drawn.

Management reserves the right to reschedule legs as may become necessary.
