FOR THREE-YEAR-OLDS THE ADMINISTRATION OF FUROSEMIDE (LASIX) WILL NOT BE PERMITTED WITHIN 48 HOURS OF POST TIME By subscription of \$100 each Early nomination made by Saturday, February 10, 2024 or \$500 each, which shall accompany the nomination made by Sunday, April 7, 2024. A Supplementary nomination fee of \$4,000 may be paid at the time of entry, which includes entry and starting fees. Original nominees to pay \$1,000 to pass the entry box and \$1,000 additional to start. All fees to be paid to the Horsemen's Bookkeeper prior to the start of the race. With \$200,000 Guaranteed to be divided 60 percent to the winning owner, 20 percent to second, 10 percent to third, 5 percent to fourth, 3 percent to fifth and 2 percent divided equally among the remaining finishers. Weights: Colts and Geldings, 122 lbs.; Fillies, 117 lbs. The Derby will be limited to fourteen (14) starters. Should more than fourteen (14) entries pass the entry box, preference will be given as follows: (1) To Graded or group winners in order (I,II,III). (2) To horses finishing 2nd or 3rd in Graded or Group Stakes in order (I, II, III). (3) Total career earnings (according to Equibase) (Restricted Stakes earnings not considered). Two horses having common ownership cannot start to the exclusion of a single ownership interest. Failure to draw into race will cancel all fees with the exception of nomination fees. Starters to be named through the entry box by the usual time of closing. Early Nominations (\$100 Fee) Closed Saturday, February 10, 2024 with 33. LATE CLOSING - Sunday, April 7, 2024 (\$500 Fee). SUPPLEMENTARY \$4,000 - Time of Entry. A TROPHY WILL BE PRESENTED TO THE WINNING OWNER. ADDITIONALLY, SHOULD THE WINNING HORSE OF THE ILLINOIS DERBY RACE IN THE 2024 PREAKNESS STAKES, HAWTHORNE RACE COURSE WILL REIMBURSE THE WINNING OWNER THE AMOUNT OF \$20,000 TO BE USED TOWARD THE PREAKNESS ENTRY FEE.
