Qualifying Standards for OVERNIGHT races Effective 7/1/24 within 60 days:

PACE: 2:00 (3 YO 2:01; 2 YO 2:02) 5/8 or 1/2 mile track allowed one second

TROT: 2:02 (3 YO 2:03; 2 YO 2:04) 5/8 or 1/2 mile track allowed one second

Drivers must hold a provisional or "A" license to participate at Suburban Downs meet
