



# The River Bear Handicap

## \$75,000 Guaranteed

A HANDICAP FOR THREE-YEAR-OLDS AND UPWARD ILLINOIS REGISTERED CONCEIVED AND/OR FOALED. No nomination fee. A Supplementary Nomination fee of \$1,500 may be paid by Saturday, September 28, 2024 which includes entry and starting fees. Original Nominees to pay \$300 to pass the entry box and an additional \$450 to start, with \$75,000 Guaranteed to be divided 60 percent to the winning owner, 20 percent to second, 10 percent to third, 5 percent to fourth, 3 percent to fifth and 2 percent divided equally among the remaining finishers. WEIGHTS: Sunday, September 29, 2024. This Handicap will be limited to 14 (fourteen) starters with no also eligibles. In the event more than fourteen (14) entries pass the entry box, preference to start will be given to horses with highest weights (scale of weights and sex allowance considered). Horses of equal weights preference will be given to the highest 2024 earnings (according to Equibase). Two horses having common ties through ownership cannot start to the exclusion of a single interest. Starters to be named through the entry box by the usual time of closing. IN THE EVENT LESS THAN SIX (6) SINGLE BETTING INTERESTS PASS THE ENTRY BOX, THIS RACE MAY BE DECLARED OFF AND ALL MONIES REFUNDED. Trophy to the winning owner.
