

## 30th Running Of The Carey Memorial \$150,000 Guaranteed

FOR THREE-YEAR-OLDS AND UPWARD No nomination fee. A Supplementary Nomination fee of \$4,000 may be paid at the time of entry which includes entry and starting fees. Original nominees to pay \$1,000 to pass the entry box and \$1,000 additional to start, with \$150,000 Guaranteed to be divided 60 percent to the winning owner, 20 percent to second, 10 percent to third, 5 percent to fifth and 2 percent divided equally among the remaining finishers. Weights: Three-year-olds, 121 lbs.; Older, 124 lbs. (Fillies and Mares allowed 3 lbs.) Winners of a Sweepstakes or Handicap with a value of \$60,000 or greater to the winner in 2024 to carry 1 lb. additional. Non-winners of two races other than maiden, claiming or starter at a mile or over in 2024 allowed 2 lbs.; non-winners of a race other than maiden, claiming or starter at a mile or over in 2024 allowed 2 lbs.; This Race will be limited to twelve (12) starters with two (2) also eligibles. In the event more than twelve (12) entries pass the entry box, preference to start will be given to horses that have the highest vice (12) entries pass the entry box, preference to start will be given to horses that have the highest (scale of weights and sex allowance considered.) Horses of equal weights preference will be given to the highest 2024 earnings (according to Equibase) (restricted races not considered.) Two horses having common ties through ownership cannot start to the exclusion of a single interest. Starters to be named through the entry box by the usual time of closing. Failure to draw into race will cancel all fees. A trophy will be presented to the winning owner. The administration of Furosemide (Lasix) will not be permitted within 48 hours of post time.
