MEET QUALIFYING STANDARDS

PACE: 2:01 (3 YO 2:02; 2 YO 2:03) 5/8 or 1/2 mile track allowed one second - within 60 days TROT: 2:03 (3 YO 2:04; 2 YO 2:05) 5/8 or 1/2 mile track allowed one second - within 60 days.

Horses shall be placed on the *Stewards' List* in the following instances:

- Break on a track rated "fast" or "good" following qualifying race. (Not applicable to horses finishing 5th or better).
- Repeated breaks: horses showing a break in two (2) consecutive starts on a track rated "fast" or "good". (Not applicable to horses finishing 5th or better in one of the two starts.
- Break in three (3) consecutive starts, regardless of track condition and/or finishing position.
- Failing to finish a race for any reason other than interference or broken equipment.
- Poor performance, as deemed by the stewards.
- Failure to meet qualifying time (Not applicable to horses finishing 5th or better).

Please refer to published conditions for late closing events and stake races as qualifying standards may differ.

Horses shall be placed on the *Vets' List* and be required to qualify in the following instances:

- Two consecutive vet scratches.
- Before, during, or after a race, a horse deemed lame by a regulatory veterinarian, must complete a qualifier to a regulatory veterinarian's satisfaction. The horse is subject to drug testing after the qualifier. At the state veterinarian's discretion, based on the horse's condition, an affidavit from the practicing veterinarian, stating the horse is fit to race, may suffice.
 - o Horses with a single sick scratch will be eligible to race on the seventh (7th) day following the sick scratch. (Excludes horses that are nominated to paid events)
 - o Horses scratched lame shall require a vet's affidavit prior to racing.
 - o Horses scratched injured shall require a vet's affidavit prior to racing.

Harness Vet's List Policy

Scratches

SICK

With vet scratch request - Eligible to Race (ETR) in 7 days

No vet scratch request (NSR) – not ETR until scratch request or Vet's List Affidavit (VLA) stating horse is fit to race is submitted to state veterinarian

Racing Sick (atrial fibrillation) – Must qualify to regulatory vet's satisfaction

INJURED

With vet scratch request by practicing veterinarian – ETR in 7 days

Without vet scratch request (NSR) – Not ETR until scratch request or VLA stating horse is fit to race is submitted to the state veterinarian

LAME

With vet scratch request by practicing veterinarian - ETR in 7 days if VLA is received stating the horse is fit to race

Without vet scratch request (NSR) – not ETR until a VLA stating horse is fit to race is submitted to the state veterinarian

Before, during, or after a race, a horse deemed lame by a regulatory veterinarian, must complete a qualifier to a regulatory veterinarian's satisfaction. The horse is subject to drug testing after the qualifier. At the state veterinarian's discretion, based on the horse's condition, an affidavit from the practicing veterinarian, stating the horse is fit to race, may suffice.

- Two consecutive vet scratches require a horse to qualify to the regulatory veterinarian's satisfaction
- Failure to Submit a vet scratch request or a vet list affidavit will result in a fine
- Exercise Induced Pulmonary Hemorrhage (EIPH) The horse will be Eligible to Qualify (ETQ) after the barred period of time has been met (1st time 14 days, 2nd time 30 days, 3nd time 180 days)
- Furosemide List Certificate of Declaration for Furosemide List must be submitted to the State Veterinarian or their designee prior to time of entry
- Pre-race Exams During the post parade, ALL horses must score down directly in front of the Regulatory Veterinarian. This area is between Barn 2 And Barn 3. This policy is for all post parades and will only be relaxed if horses are going directly to the gate.
