**FOR FILLIES AND MARES, THREE-YEARS-OLD AND UPWARD** THE ADMINISTRATION OF FUROSEMIDE (LASIX) WILL NOT BE PERMITTED WITHIN 48 HOURS OF POST TIME. No nomination fee. A Supplementary Nomination fee of \$2,000 may be paid at the time of entry which includes entry and starting fees. Original Nominees to pay \$500 to pass the entry box and an additional \$500 to start, with \$100,000 Guaranteed to be divided 60 percent to the winning owner, 20 percent to second, 10 percent to third, 5 percent to fourth, 3 percent to fifth and 2 percent divided equally among the remaining finishers. In the event the field goes to the gate with 5 horses or less, the purse will be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights: Three-Year-Olds, 120 lbs.; Older, 124 lbs. Winners of a Sweepstakes or Handicap with a value of \$60,000 or greater to the winner in 2025 to carry 1 lb. additional. Non-Winners of 2 races other than maiden, claiming or starter in 2025 allowed 3 lbs. Non-winners of a race other than maiden, claiming or starter in 2025 allowed 5 lbs. This Race will be limited to twelve (12) starters with two (2) also eligibles. In the event more than twelve (12) entries pass the entry box, preference to start will be given 1) to horses that have the highest weights (scale of weights considered.) 2) Horses of equal weights preference will be given to the highest earnings in 2025 (according to Equibase). Two horses having common ties through ownership cannot start to the exclusion of a single interest. Failure to draw into the race will cancel all fees. Starters to be named through the entry box by the usual time of closing. Trophy to the winning owner.
