

## 54th Running Of The Hawthorne Derby \$150,000 Guaranteed

FOR THREE YEARS OLD THE ADMINISTRATION OF FUROSEMIDE (LASIX) WILL NOT BE PERMITTED WITHIN 48 HOURS OF POST TIME. No nomination fee. A supplementary nomination fee of \$3,000 may be paid at the time of entry, which includes entry and starting fees. Original nominees to pay \$750 to pass the entry box and an additional \$750 to start, with \$150,000 Guaranteed to be divided 60 percent to the winning owner, 20 percent to second, 10 percent to fourth, 3 percent to fifth and 2 percent divided equally among the remaining finishers. In the event the field goes to the gate with 5 horses or less, the purse will be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights, Colts & Geldings, 124 lbs. Fillies, 121 lbs. The Derby will be limited to twelve (12) starters, with two (2) also eligibles. Preference will be given as follows: (1) to Graded or Group winners in order (I, II, III); (3) Highest Career earnings (according to Equibase) (restricted races not considered.) Two horses having common ownership cannot start to the exclusion of a single ownership interest. Failure to draw into race will cancel all fees. Starters to be named through the entry box by the usual time of closing. A trophy will be awarded to the winning owner. The administration of Furosemide (Lasix) will not be permitted within 48 hours of post time.
