FOR FILLIES AND MARES, THREE-YEARS-OLD AND UPWARD ILLINOIS REGISTERED CONCEIVED AND/OR FOALED. THE ADMINISTRATION OF FUROSEMIDE (LASIX) WILL NOT BE PERMITTED WITHIN 48 HOURS OF POST TIME. No nomination fee. A Supplementary nomination fee of \$1,500 may be paid at the time of entry; which includes entry and starting fees. Original Nominees to pay \$300 to pass the entry box and an additional \$450 to start, with \$75,000 Guaranteed to be divided 60 percent to the winning owner, 20 percent to second, 10 percent to third, 5 percent to fourth, 3 percent to fifth and 2 percent divided equally among the remaining finishers. In the event the field goes to the gate with 5 horses or less, the purse will be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights: Three-year-olds, 121 lbs.; Older, 125 lbs. Winners of a Sweepstakes or Handicap with a value of \$60,000 or greater to winner in 2024-25 to carry 1 lb. additional. Non-winners of \$45,000 in 2024-25 other than maiden, claiming or starter allowed 3 lbs. Non-winners of \$35,000 other than maiden, claiming or starter in 2024-25 allowed 6 lbs. This race will be limited to 14 (fourteen) starters with no also eligibles. In the event more than fourteen (14) entries pass the entry box preference to start will be given 1) Horses with highest weights (scale of weights considered). 2) Horses of equal weights preference will be given to the highest 2025 earnings (according to Equibase). Two horses having common ties through ownership cannot start to the exclusion of a single interest. Starters to be named through the entry box by the usual time of closing. IN THE EVENT LESS THAN SIX (6) SINGLE BETTING INTERESTS PASS THE ENTRY BOX, THIS RACE MAY BE DECLARED OFF AND ALL MÖNIES REFUNDED. Trophy to the winning owner.
