ENTRIES: Telephone entries are made at the owner's and/or trainer's risk. Responsibility of lost or misplaced entries will be placed solely on the person making said entry via telephone. Entries will close at 11:00 a.m. – No exceptions. The drawing of the races will be at 11:30 a.m. With any and all disputes, the Stewards shall make the final decision.

**NO ENTRIES WILL BE ACCEPTED WITHOUT DOCUMENTED PROOF OF A NEGATIVE COGGINS TEST AND CURRENT EHV-1 VACCINATION.**

All Jockey Agents making entries must be so before 10:00 a.m.

**ALL HORSES, INCLUDING PONIES, NEED THE FOLLOWING PAPER WORK TO BE ON THE GROUNDS:**

- All horses are required to have a Certificate of Veterinary Inspection (Health Certificate) within 5 days of entry.
- All horses on the grounds should have a negative Coggins test within the last 365 days.
- All horses on the grounds MUST be vaccinated for EHV-1 within the last 180 days, Vaccination for EHV-1 is required twice a year.
- **NO ENTRIES WILL BE ACCEPTED WITHOUT DOCUMENTED PROOF OF A NEGATIVE COGGINS TEST AND CURRENT EHV-1 VACCINATION.**

**The preference date system will be utilized at Hawthorne, Refer to the back of the condition book for rules.**

**ILLINOIS HORSES ENTERED IN OPEN CLAIMING RACES MUST DECLARE THEIR CLAIMING PRICE (Either BASE CLAIM OR ILLINOIS RAISE) AT THE TIME OF ENTRY.**

**REGISTRATION OF HORSES:** After horses have been registered with the racing secretary's office listing their ownership, no horse will be transferred (unless claimed at the meet racing at the time.) without permission of the Stewards who may require a notarized Bill of Sale.

**TATTOOING:**

All horses must be tattooed to start. The cost of tattooing a horse is \$115 which must be paid to the Horsemen's Bookkeeper prior to the horse being tattooed. Lip Tattooing has been replaced with Digital Tattoo (Picture Horse ID) which is accessible through scanning of the Jockey Club issued Microchip that has been implanted in the horses' neck by the breeder. The process will be as follows:

- All foals must be microchipped before the Jockey Club will register the horse.
- Like the current system the TRPB Identifier will come to your barn; then scan the microchip to pull up the digital copy of the foal papers and verify the markings prior to your horse being allowed to race. Additionally, the TRPB Identifiers will take a series of photographs of your horse.
- The TRPB Identification fee will be \$115 to be paid to the Horsemen's Bookkeeper.
- PLEASE NOTE: Absolutely no microchipping can be completed the day of the race.

**COGGINS TEST/EHV VACCINATIONS:** No horse will receive a date without a current negative Coggins test on file in the Racing Office. All horses racing in Illinois must have a negative Coggins test within the past twelve months and proof of EHV vaccination, current not closer than 14 days or longer than 180 Days.

**CONDITION ELIGIBILITY PREFERENCE:**

**(a) MAIDEN RACES:** Preference to horses that have not started for less than \$20,000. The same preference will be given to horses that have started for less than \$20,000 and since have finished 2<sup>nd</sup>, 3<sup>rd</sup> or 4<sup>th</sup> for \$20,000 or more.

**(b) ALLOWANCE RACES:** Condition Eligibility consists of a preference to horses that are eligible for each specific condition (Example: a 2XMC is 1<sup>st</sup> preference, next 1XMC, etc.) Winners who have raced for a Claiming Price of less than

\$13,500 will not have preference, unless they have thereafter finished first, second, third or fourth for \$13,500 or more.

**(c) OPTIONAL ALLOWANCE/CLAIMING RACES:** Horses that are eligible for each specific condition (Example: 4XMC is first preference, next 3XMC) are preferred. The same preference will be given to horses that are entered for the optional claiming price and share the same lifetime condition or have won that condition and have not started for a claiming price of less than \$13,500 unless thereafter finishing first, second, third or fourth for \$13,500 or more.

**WEIGHTS:** Winners or non-winners of a stated sum means winner or non-winners of a single race of that value to the winning horse. Allowance claimed at the time of entry may not be waived after publication of the overnight, except with permission of the Stewards. Penalties are obligatory. Allowances are option as to all or any part thereof and must be claimed at the time of entry. Horses penalized in a race shall not be entitled to any of the allowances in such race. Horses not entitled to the first allowance are not entitled to the second or any subsequent allowance specified in the conditions of the race. Under the universal rules of racing an owner or trainer is responsible for the weight his horse carries

**NAMING OF JOCKEYS:** Each horse drawn into a race shall have its jockey named at time of entry and prior to the publication of the overnight. If a jockey is named on two horses (one of the also eligible list) the agent shall designate first and second call at time of entry with a back up rider named behind the second call. An apprentice allowance may only be claimed before entries have closed and only if the apprentice has been engaged. Should a jockey remain unnamed at the drawing of entries, the racing office shall make a reasonable effort to contact the trainer. If this attempt fails, the stewards or designee will name a jockey. Only the trainer of the horse or the person who has made the entry of said horse shall have permission to change or name a rider at the draw. No jockey once named shall be changed except for good cause by the Stewards. Any such change may be subject to penalty.

**TURF RACE ENTRIES:** In turf races limited to ten starters as many as four also eligible will also be carded to turf and dirt races limited to twelve, as many as two also eligible will also be carded. If there are any scratches, the morning of the race, the also eligible horses will be permitted to move into the race in order of their preference, which will be determined at the drawing of entries. (Example) Post Position #11 has first preference and Post #12 second preference, etc. At the

discretion of management, based on weather forecasts, entries will be accepted in turf races (excluding Stakes) including Overnight Stakes and Overnight Handicaps for Dirt Preferred horses (Main Track only). Trainers must declare the horse is Dirt Preferred at time of entry. If a scheduled turf race is taken off the turf, the also-eligible list of MAIN TRACK ONLY ENTRIES will move into the body of the race up to 12 (twelve) horses. A Dirt Preferred entry has no preference to draw into a Turf Race as a starter over a Turf entry and will be carded as an also eligible at all times even if the race does not overfill. For Program information the Dirt Preferred horses will be listed as MTO (Main Track Only). At the discretion of management, based on weather forecasts, in over-filled Turf Races the also-eligible list shall be composed of first, Dirt Preferred entries and then Turf entries. If the race is removed from the turf, Dirt Preferred also-eligible will have first preference (By their Date). If a race remains on the Turf, Dirt Preferred horses, regardless if the race is overfilled or not will not be eligible to start.

**TURF COURSE:** If it is deemed inadvisable by the Management or its officers to run a scheduled Turf Race on the turf, it will be transferred and run on the main track, distance as follows:

**TURF** – Seven and One-Half Furlongs will be One Mile and Seventy Yards.

**TURF** – One Mile will be One Mile and Seventy Yards.

**TURF** – One Mile and One-Half will be One Mile and One Quarter.

**SHOE POLICY – BOTH TURF AND DIRT (HISA RULE 2276)**

Traction devices include but are not limited to rims, toe grabs, bends, jar calks and stickers.

**CHANGE OF EQUIPMENT:** When blinkers are removed or added under the ‘Change of Equipment’ caption, and said horse is a late scratch, the blinker change is negated. Consequently, the change of equipment must be designated again at time of entry for blinker privileges to be reinstated. Any change of equipment must be approved by the Stewards. You must have a Change of Equipment card signed by the Starter, which must be submitted at time of entry with the change so designated on the entry blank or with approval of the Stewards the change may be made before the official program goes ‘final’. If using any type of blinkers, the cup must measure a minimum of one inch.

**RACE DAY PADDOCK:**

- (a) All horses should arrive to the paddock no later than 15 minutes before post time of their race
- (b) All non-racing bandages must be removed upon entering the paddock.

**VET WORKS:**

Working for the Regulatory Veterinarians will be done by appointment. Vets are available to watch works on dark draw days. Prior to making an appointment to work for the Regulatory Veterinarian, you will need your attending Veterinarian to examine and jog your horse.

**RACE DAY PRE-RACE EXAMS:**

- All horses must be jogged before pre-race examinations.
- Ship-ins please notify the stable security office of your location for pre-race exams and Lasix administration.
- All horses into race should have a security sign by their stall indicating they are in to race. Failure to do so will result in a fine.
- All ship-ins must be on the grounds prior to 11:00 AM on the day they race.

**WORKOUT RULES:** Horses which haven't raced in thirty days need one official work. First time starters need three official works. All horses entering the track for training shall be identified by name, type of workout, distance and name of trainer. Failure to report this information to the gap attendant or clocker will be referred to the Stewards.

**TRAINER LICENSE WORKMEN'S COMPENSATION REQUIREMENT:** All applicants for a trainer's license in Illinois must comply with Illinois Racing Board Rule 502.220 requiring Workmen's Compensation in Illinois. There are no exceptions, even if a trainer has no employees or is not required to carry workmen's compensation in his or her own state.

**RACE DAY SECURITY OF HORSES RACING:** (Illinois Racing Board Rule 603.70 (I) (F): Trainers are required to ensure your horse that is in to race is always guarded after receiving Lasix until the horse can be taken to the paddock. Horses found unguarded will be scratched. Horses not on Lasix will have to be in its stall posted with a Security sign two hours prior to post time. Trainers are responsible for obtaining your Security Signs from the Stable Security Office.

**SCRATCHES:** (Illinois Racing Board Section 1413.140 Right to Declare out).

- a) In purse races and overnight handicaps with more than nine (9) interests, trainers shall have the right to declare out to that number before the time stipulated by the regulations of the

operator on the day of the races. When more than one trainer expressed the desire to declare out, the right to declare out shall be determined by lot. Declarations below nine may only be made by permission of the Stewards when a note from a veterinarian establishes a medical reason to excuse the horse from the race or when there is a request from the Racing Secretary to fill a different race. Any also eligible shall have the preference to scratch over regularly carded horses. Trainer declarations will only be considered following the time at which the removal of horses from a race has been received by the Stewards from veterinary related scratches.

b) Horses may be scratched out of Stake Races not later than forty-five (45) minutes before post time of the race.

c) Scratched horses may be subject to being placed on a 10-day waiting list to enter by the Stewards if deemed necessary. Additionally, Veterinarian scratches are subject to follow-up inspection by either the State or Association Veterinarian.

**LASIX RULE: Illinois Racing Board:**

A Horse qualifies to race with Lasix in Illinois if:

1. A valid Bleeder Certificate is presented to the Security Coordinator at the IRB Office or the State Vet.
2. A Veterinarian Licensed by the IRB concludes that it will be in the best interest of the horses to race with Lasix and it is approved by the IRB State Vet.
3. The past performance lines show that the horse has been consistently racing with Lasix.
4. By signing an affidavit stating that the horse has bled in another jurisdiction; within 10 days presenting proof of it, or forfeiting any earned purse money plus a fine and/or suspension.

**CLAIMING PROTOCOL:** Only claiming cards using the HISA template will be valid. All claims must be deposited in the claim box located in the paddock at least 10 minutes before post time or in the time fixed for the race to begin and not later. No official of the Association shall give any information as to the filing of claims therein until the race has been run. When a claim is filed, it is irrevocable and at the risk of the claimant. Determination of the true age and sex of a claimed horse shall be the sole responsibility of the claimant. It is the Trainer's responsibility to turn in the foal papers for any horse claimed and must be turned in to the office within 48 hours of the claim. The Horsemen's Bookkeeper will have a hold on all claimed money until the papers are turned into the Racing Office.

**CLAIMING RULES:**

A) For a period of 30 days after the claim of a thoroughbred horse, the horse may race for the same claiming price or higher



than the price at which it was claimed. The horse is eligible to run back for a lesser price on the 31<sup>st</sup> day after the claim.

b) Starter Handicap or Starter Allowance races are not subject to subsection (a).

c) A horse claimed out of a claiming race is not eligible to race in any other state other than Illinois for a period of 45 days from the date of the claim, or until a date following which the racing season has concluded. This section shall not apply when claimed horses are fulfilling a Stakes engagement or have the express written consent of the race track where they were claimed to race at another location. No horse claimed in a claiming race shall be sold or transferred wholly or in part to anyone within 30 days after the day it was claimed, except in another claiming race.

#### **TRANSFER OF CLAIMED HORSE RECORDS (HISA Rule 2261)**

(a) Entry of Horses subject to being claimed in a Claiming Race implies Owner (Trainer as the agent of the Owner) consent for transfer of all Trainer and veterinary examination and treatment records for the last 60 days to the new Trainer of the claimed Horse.

(b) If a Horse is successfully claimed by a new Trainer, the previous Trainer must transfer Trainer records and authorize transfer of veterinary records to the new Trainer within 3 days of transfer of the Horse to the new Trainer.

#### **VOID CLAIMING RULE (HISA Rule 2262)**

Claims are voided if the Horse dies, is euthanized, bled, is vanned off the racetrack, or is later found to test positive for a prohibited substance. Additionally, all claimed horses go to the test barn for observation by a Regulatory Veterinarian. If a Regulatory Veterinarian determines within 1 hour of the race that the horse will be placed on the Veterinarians' List as bled, physically distressed, medically compromised, unsound, or lame before the Horse is released to the successful claimant, the claim is void. Claims will not be voided if the Claimants elect to claim the horse regardless of whenever the Regulatory Veterinarian determines the horse will be placed on the Veterinarians' list as bled or unsound or the Horse tests positive for prohibited substance.

#### **HISA RULE 2262 (g) and (h): CLAIMS VOIDED FOR**

**MEDICATION FINDINGS:** In the case of a post-race medication test in a horse that was claimed, the claimant will be notified of their option to void the claim. Claimants have 48 hours to provide written notice to the Stewards at the track where the horse was claimed that they wish to void the claim.

Claimants who claim a horse may complete and submit the "Void Claim Test Result Inquiry Form" located on HISA's

website to determine the status of the testing results of any post-claiming race sample collection.

If the claimant chooses to void the claim, they will be entitled to return of the claim money, as well as documented and reasonable expenses related to the care and training of the horse since the date of the claim.

However, a claim will not be voided if any of the following have occurred after the claim:

- The horse has started in a subsequent race.
- The claimant failed to exercise due care with or made material alterations to the claimed horse; or
- The claimed horse has died or is euthanized.

#### **HISA WAIVER CLAIMING OPTION RULE 2263:**

At the time of entry into a claiming race, the owner, or the trainer acting under authorization from the owner, may opt to declare a horse ineligible to be claimed provided that:

a) The horse has not been an official starter in a race at any racetrack for a minimum of 120 days since it's last race as an official starter.

b) The horse's last race as an official starter was a claiming race in which the horse was eligible to be claimed.

c) The horse is entered for a claiming price equal to or greater than the claiming price at which it last started;

d) failure to declare the horse ineligible may not be remedied.

e) A horse is eligible to run for a waiver claiming for a second consecutive race provided the waiver was declared for the first race back and the horse is entered for a claiming price equal to or greater than the price for which it last started. The horse is ineligible for the second waiver if it wins the first race back or it changes majority ownership after its first race back. A horse who is running for the waiver claiming and wins will have the win considered a Starter Allowance win for future conditions.

#### **REQUIRED SAFETY EQUIPMENT**

All personnel on horseback (including trainers, assistant trainers and/or foremen who are taking sets to the track as well as jockeys, exercise riders and pony personnel) must wear an approved Safety Helmet with the chinstrap fastened along with an approved Safety Vest at all times.

### **VETERINARIANS' LIST (HISA RULE 2240)**

a) A Veterinarians' List shall be maintained by the Authority of all Horses that are determined to be ineligible to compete in a Covered Horse Race in any Jurisdiction until released by a Regulatory Veterinarian.

b) The following Horses shall be placed on the Veterinarians' List until removed in accordance with Rules 2241 and 2242.

(1) Hoses affected by illness, physical distress, medical compromise, unsoundness, injury, infirmity, heat exhaustion, positive test or overage administration of a medication invoking a mandatory stand down time, administration of Shock Wave Therapy, positive out-of-competition test or any other assessment or determination by Regulatory Veterinarians that such Horse is unfit to race;

(2) Horses which have not started in more than 365 days; and

(3) Horses which have not made a start prior to January 1 of their 4-year-old year.

c) Trainers and Owners shall be notified in writing within 24 hours that their Horse has been placed on the Veterinarians' List.

d) Diagnostic testing may be required for any Horse placed on the Veterinarians' List, at the discretion of the Safety Director, Regulatory Veterinarian, or Association Veterinarian.

### **HISA RULE 2241: Duration of Stay on the Veterinarians' List.**

Horses placed on the Veterinarians' List in accordance with Rule 2240 shall remain on the List as follows:

(a) Horses placed on the Veterinarians' List for unsoundness or Epistaxis shall remain on the list for 14 days.

(b) Horses placed on the Veterinarians' List multiple times for unsoundness within the previous 365 days shall remain on the list for 45 days for the second time, 75 days for the third time, and shall be barred from further racing after the fourth time.

(c) Horses placed on the Veterinarians' List multiple times for Epistaxis within the previous 365 days shall remain on the Veterinarians' List for 30 days for the second time, 180 days for the third time and shall be barred from further racing for the fourth time.

(d) Horses placed on the Veterinarians' List for illness shall remain on the list for 7 days.

(e) Horse treated with Shock Wave Therapy shall be placed on the Veterinarians' List for 30 days.

(f) If before, during or after the workout for removal from the Veterinarians' List, the horse is deemed to be unsound or to have Bled, the stay on the Veterinarians' List shall be extended an additional 14 days and further diagnostic testing may be required as determined by the Regulatory Veterinarian.

## **HISA RULE 2242: Removal of Horses from the Veterinarians' List**

Regulatory Veterinarians may remove Horses from the Veterinarians' List in accordance with Rule 2242 and shall document such removal to the Authority.

(a) A Horse placed on the Veterinarians' List as unsound or suffering from Epistaxis may be removed from the Veterinarians' List upon satisfaction of paragraphs (1) and (3) below.

(1) A trainer must apply to the Regulatory Veterinarian for permission to work the Horse for removal from the Veterinarians' List. Upon receiving such approval, the Trainer and Attending Veterinarian must observe the Horse jog and submit to the Regulatory Veterinarian a co-signed statement that the Horse is fit to perform a workout.

(2) The Horse must perform a Workout under the supervision of the Regulatory Veterinarian and demonstrate to the satisfaction of the Regulatory Veterinarian that the Horse is sound to race.

(3) The Regulatory Veterinarian determines there is no evidence or signs of Epistaxis, physical distress, medical compromise, unsoundness or lameness within 1 hour after the workout conducted pursuant to paragraph (a)(2) above.

(b) A horse placed on the Veterinarians' List as physically distressed or medically compromised may be removed from the Veterinarians' List provided sound health has been declared by the attending Veterinarian or demonstrated to the Regulatory Veterinarian and documented to the Authority.

(c) In addition to the requirements (c) set forth herein and any requirements of the Protocol, if a Horse is placed on the Veterinarians' List for a positive test or overage of a primary substance invoking a mandatory stand down time, a positive out-of-competition test, or any other veterinary administrative withdrawal, the Horse shall be prohibited from entering a race and may be released from the Veterinarians' List only after also undergoing a post workout inspection by the Regulatory Veterinarian.

## **HISA RULE 2142 (a): Post Layoff Report for Horses that have not raced for 150 or more days.**

Any trainer responsible for a Covered Horse that has not raced for 150 or more days is required to complete a Layoff Report and submit it to the Authority prior to entry.

Trainer Information

### **HISA RULE 2282: Riding Crop Violations and Penalties**

(a) Violation of Rule 2280 shall be categorized as follows, with the exception that use of the crop for the safety of horse and rider shall not count toward the total crop uses.

- (1) Class 3 Violation –1 to 3 strikes over the limit.
- (2) Class 2 Violation –4 to 9 strikes over the limit
- (3) Class 1 Violation – 10 or more strikes over the limit.

(b) Unless the Stewards determine the merits of an individual case warrant consideration of an aggravating or mitigating factor, the penalties for violations are as follows:

- (1) Class 3 Violation –
  - (i) \$250 or 10% of Jockey's portion of the purse, whichever is greater.
  - (ii) Minimum 1-day suspension for the Jockey, and
  - (iii) 3 Points
- (2) Class 2 Violation--
  - (i) \$500 or 20% of Jockey's portion of the purse, whichever is greater;
  - (ii) Horse disqualified from purse earnings,
  - (iii) Minimum 3-day suspension for the Jockey; and
  - (iv) 5 Points.
- (3) (i) \$750 fine or 30% of Jockey's portion of the purse whichever is greater;
  - (ii) Horse disqualified from purse earnings.
  - (iii) Minimum 5-day suspension for the Jockey;
  - (iv) 10 Points

#### **BAN ON HORSE SLAUGHTER:**

Any horsemen stabled at Hawthorne found to have directly sent a horse for slaughter may be subject to the following loss of stalls at Hawthorne, loss of ability to race at Hawthorne, fine and/or license revocation. Hawthorne requires Horsemen to conduct due diligence on those buying horses and encourages them to support horse rescue and adoption efforts. Hawthorne asks that horsemen contact Galloping Out or look to find humane ways of dealing with horses unable to continue racing.

## **ILLINOIS-REGISTERED OWNERS' AWARDS**

### **\*IOA\***

As a part of 1995 legislation, the Illinois Horse Racing Act provides monetary incentives to the owners of Illinois-registered thoroughbreds placing first, second and third in select open company races in Illinois. The races which qualify are: allowance races, overnight handicaps, maiden special weights, and claiming races with claiming prices of \$10,000 and up.

## **ILLINOIS CONCEIVED AND FOALED**

### **\*IB\***

The amount of Owners' Award is sixty percent of the earned portion of the purse for an Illinois Conceived and Foaled (IB) horse that qualifies. Only those horses which are sired by Illinois-registered stallions and are registered with the Illinois Department of Agriculture as Illinois Conceived and Foaled are eligible for this 60% bonus.

## **ILLINOIS FOALED**

### **\*IF\***

The amount of Owner's Award for an Illinois Foaled (IF) horse is 40% of the earned portion of the horse 1st thru 3rd.

## **ENTRY PERMIT NUMBER REQUIRED FOR EQUINE ENTERING ILLINOIS**

Effective February 1, 2004, all equine entering Illinois (for any reason other than slaughter) must be accompanied by a negative test for EIA conducted within a year if the animal is more than one year of age, certificate of veterinary inspection (health certificate) issued by an accredited veterinarian with 5 days of entry, and an entry permit number issued by the Illinois Department of Agriculture. This new requirement comes on the heels of the Monkey Pox and Mad Cow reports and is part of a nationwide attempt to track the movement of livestock, including horses, throughout the country.

Entry permits are available by calling the Illinois Department of Agriculture, 217-782-4944 and are issued 24 hours a day, seven days a week. Permit numbers are also available online at [www.agr.state.il.us](http://www.agr.state.il.us). A password to access the permit program is required and will be issued to veterinarians by calling the Illinois Department of Agriculture, Bureau of Animal Health, 217-782-4944 weekdays, 8:00 am - 4:30 pm. The following information will be required for the entry permit number:

- Name and mailing address of the owner of the animal;
- Date of the EIA test;
- Location where the animal is going.

**THERE IS NO CHARGE FOR OBTAINING AN ENTRY PERMIT NUMBER FROM THE ILLINOIS DEPARTMENT OF AGRICULTURE.**

Please note: A certificate of veterinary inspection and entry permit are not required for equine residing in Illinois full time.

For equine only: The entry permit number is good for 30 days (the life of the health certificate).

### **HEALTH CERTIFICATES**

Hawthorne Race Course will require a valid Health Certificate within five (5) days of arrival for all horses prior to entry on the racetrack. The Health Certificate must include the horse's rectal temperature, the EHV date and product name and a current Coggins test results. Please be advised that this includes horses shipping in from any Illinois facility.

# STATE OF ILLINOIS REQUIREMENTS FOR HORSES RACING AT HAWTHORNE RACE COURSE

The following are requirements to enter on to the race-track grounds:

**1. A valid Certificate of Veterinary Inspection (Health Certificate):**

- Issued within five (5) days prior to entry
- Including valid rectal temperature
- **Vaccinated for EHV-1** (Rhinopneumonitis) by licensed veterinarian, with the date of vaccination listed on the health certificate, that is within the last **One Hundred and eighty (180) days and not less than fourteen (14) days prior to entry**, and product use.

**2. Negative Coggins within the last twelve (12) months.**

**3. Illinois Entry Permit Number on the Certificate of Veterinary Inspection** (Health Certificate), obtained from the Illinois Department of Agriculture; telephone number (217) 782-4944.

**HISA RULE 2143: ALL HORSES ENTERING THE GROUNDS INCLUDING STABLE PONIES MUST HAVE:**

a) Health Certificate by a veterinary inspection within 5 days or fewer if high risk situations dictate.

1) Verification of EEE/WWE/WNV (Encephalitides), rabies and tetanus vaccinations within the prior 12 months

2) Verification of Influenza and Rhinopneumonitis vaccinations within the prior 180 days or fewer days if high risk situations dictate

3) A current negative Coggins Test within the prior 12 months

**ILLINOIS RACING BOARD RULE**

**Section 605.60 Equine Herpesvirus (EHV-1)**

All horses, including ponies, entering or stabling on the grounds of any pari-mutuel racetrack in Illinois shall have documented proof of EHV-1 vaccination administered within the prior 180 days. No entries shall be accepted by the Racing Secretary without documented proof of a current EHV-1 vaccination. The Racing Secretary shall maintain records to substantiate current vaccinations of all horses entering or stabling on the grounds.

## **PREFERENCE DATE SYSTEM**

**NO ENTRY WILL BE ACCEPTED ON A HORSE WITHOUT AN UP-TO-DATE EHV VACCINATION AND NEGATIVE COGGINS ON FILE IN THE RACING OFFICE.**

1. Under the Preference Date System, a horse will receive both an Entry Date Dirt (Example 1D) and an Entry Date Turf (Example 1T). Subsequently a running Date (R1D or R1T) or a Scratch Date (Example S1D or S1T). Preference will be given to the horses with the earliest dates. When a horse with an Entry Date has the same date as a horse with a Running Date, the horse with the Entry Date has preference. When a horse with a Running Date has the same date as a horse with a Scratch date, the horse with the Running Date has Preference.
2. Horsemen can establish an Entry Date for their horses by registering their foal papers, along with a valid negative Coggins Test and proof of current EHV vaccination to the Racing Office. In which case the horse will receive an E-Date corresponding to the date they are turned in. The earliest date being (0). If foal papers are received before 2:00 p.m., Tuesday, March 27, 2026, the horse will receive a (0) date. Foal papers received after that time, or on Sunday, March 29 will receive a (1) Date. If foal papers are registered on a non-racing day, the next racing date will be given.
3. A running Date is established when a horse draws into a race in which case the horse will receive a date corresponding to the day the race is scheduled to run.
4. Horses that are scratched out of the body of a race will receive a Scratch Date for the day they were scheduled to run.
5. A horse that runs in a race taken off the turf will retain its Turf Date and establish a R-Date (Dirt). A scratched horse will receive a S-Date for both Turf and Dirt.
6. Any Horse scratched from the also eligible list will retain its previous date unless scratched due to ineligibility.
7. A horse can have only one date preference for each category (Dirt/Turf).
8. Horses that have established a date at the current meeting will lose their date should their foal papers be withdrawn or if they run at another racetrack.
9. In no way does a claim, transfer of owner or trainer affect the preference date of a horse.
10. Preference must be claimed at the time of entry.
11. In all winners' races winners are preferred.
12. Preference Dates do not supersede the conditions of a race.
